# A Message from Leadership

Dear Friends,

As you know, Safe Harbor sees children and families in what is often their darkest hour. The abuse of a child is gut-wrenching: for the child who trusts someone who hurt them; for the non-offending parent/caregiver who wasn't able to protect them; and for our staff, who is a rock among the waves, offering them advocacy, forensic interviews, crisis intervention, and support.

Sometimes people ask why we do these difficult jobs. And the answer is always the same: we are called to make a difference. Our dedicated, expert staff is steadfast in their dedication to help the child and family get on the road to safety and healing. These families are often isolated from friends and family- abuse is not something people readily share with even those closest to them. Our unflinching presence tells them they can share anything with us, and we are here to help.

In 2022 we served 428 children and 426 caregivers. That is a 6% increase from the previous year and continues our trajectory of growth. In the past 5 years we have seen a 27% increase.

We are always looking for how we can best serve the children and families in our community. In the Fall of 2022, Safe Harbor staff and Board of Directors engaged in a facilitated strategic planning process to create goals and objectives for the next 5 years. A few key themes emerged: provide more trauma treatment on site (most of our families are referred to community partners for ongoing mental health services); build stronger partnerships with neighboring counties to better serve those children; improve engagement with communities of color in order to build stronger partnerships and better serve children who may be underserved. I look forward to reporting progress on those goals in the next annual report.

The critical services that Safe Harbor provides couldn't happen without the support of our all-volunteer Board of Directors, and the generosity of private donors, foundations, and government funders. We are grateful to our community for ensuring that Safe Harbor is here to serve for years to come.

# **Our Mission & Services**

### **OUR HISTORY**

Safe Harbor Child Advocacy Center opened in 1999. We are the only Child Advocacy Center in Dane County. There are 16 Child Advocacy Centers in Wisconsin and over 900 nationwide. Law enforcement, child protection, prosecutors, and medical providers come together to this single location to collaborate and ultimately reduce the number of times the child has to share and relive their story. Since opening our doors, we have served more than over 5,000 children and their families free of charge.

# **OUR MISSION**

Safe Harbor seeks to reduce the trauma to children who are victims of abuse or neglect or witnesses to crimes, by promoting the coordination of multidisciplinary investigations, conducting forensic interviews in a child-friendly environment, and providing ongoing advocacy to affected children and families.

## **OUR SERVICES**

Our services are engaged through referral from law enforcement or child protective services.

Forensic Interviews in a Child-Friendly Environment

Safe Harbor provides a safe and friendly place for a child to talk about what has happened to them. Safe Harbor forensic interviewers are highly trained in best practice interviewing methods and child development. The forensic interview is video recorded, so that the statement can be considered for use in court.

Ongoing Advocacy to Affected Children & Families Safe Harbor provides family advocacy services to non-offending caregivers of children who are interviewed at Safe Harbor. Family Advocates provide support for caregivers both at the time of the interview and on an ongoing basis. In addition, Family Advocates can voice concerns of the caregiver to the investigative team.

Family Advocates provide families with quick access to mental health services through referral to immediate crisis counseling and/or longer term treatment. Family Advocates assist the team and the family in considering and scheduling important medical exams at Meriter's Forensic Nurse Examiners Program or the UWHealth Child Protection Program at American Family Children's Hospital. Many families who attend Safe Harbor are in need of basic resources. Family Advocates connect families with Emergency Assistance funds such as gas and grocery gift cards, rental assistance, energy bill assistance, and more.


Promoting the Coordination of Multidisciplinary Investigations


Safe Harbor brings together a multidisciplinary team of professionals with the philosophy that collaboration is essential for an effective investigation and intervention process.

# **Forensic Interviews**

Safe Harbor provided **428 child forensic interviews** in 2022. The chart below shows the number of interviews each year since Safe Harbor was founded.


# **Forensic Interviews of Children**





The chart to the left illustrates the breakdown of forensic interviews at Safe Harbor in 2022 by maltreatment type. The vast majority of cases involve allegations of sexual abuse, followed by physical abuse, witness to violence, neglect, and drug endangered children cases.

The pie charts to the right show clients by age and race in 2022. The majority of abuse victims are 12 years old or younger. Based on mental health referrals, we observed that ~75% of clients identify as female and ~25% identify as male.



# **Advocacy & the Team Response**

# **Family Advocacy**

Family Advocates provided services to 421 caregivers in 2022. This work entailed making 2,985 contacts with caregivers and others on their behalf over the course of 2022.

## **Referral to Mental Health Treatment**

A critical service to help traumatized children heal is traumafocused mental health treatment. Safe Harbor facilitates and funds mental health assessments as well as crisis counseling for child abuse victims and their caregivers. In 2022 Safe Harbor was able to increase the services we could provide to families in need. These services are expedited, without barriers and geared specifically for traumatized children. In 2022, Family Advocates made 164 referrals for mental health services.




# **Protocol for the Multidisciplinary Team Response**

In addition to providing services, Safe Harbor coordinates county-wide best practice protocols. An important goal is to institutionalize best practices, so that there are clear standards and expectations for all the systems that come into play when child abuse is exposed. These protocols include child abuse response, drug endangered children, and commercial sex trafficking. Safe Harbor also coordinates monthly case reviews, to ensure that the protocols are being followed and the team is working together effectively.

Safe Harbor serves Dane County. However, we also provide services to other counties as a courtesy if the child lives in Dane County or there is no Child Advocacy Center available in the county where the incident occurred. In 2022, Safe Harbor provided 157 courtesy interviews for outside counties.




**Grant and contract Revenue:** \$606,174 [59%]
